Description:

This position would be responsible for operating equipment ranging from the sprayer, spreader, anhydrous applicator, and semi with tanker and hazmat requirements. Additional work required will include, but is not limited to: equipment maintenance, record/log keeping, creating and uploading maps.

Hour Requirements:

Off-season: Monday – Friday, 7:30 AM – 4:30 PM

In-season (September – December & March – July): In-season hours are dependent upon workload and may be extended due to seasonal demands. During peak seasons, hours may extend to 80+/week depending on weather conditions and workload.
